The Hon'ble High Court of Bombay in MCA No. 293 of 2011 in Stamp No. 109/11 have sought information with respect to the Status of constituting a Committee as directed by Hon'ble High Court in MCA No. 882 of 2010 in the case of Executive Engineer, WD-VI (R.S.), PWD, Fatorda, Margao & other v/s Comunidade of Cortalim dated 28-02-2011.

2. It has been observed that there is inordinate delay in filing Appeal in the Hon'ble High Court

by the State against the judgment and award passed by the Hon'ble District Judge. The Hon'ble High Court has observed that there is considerable delay in filing Appeal by the State and directed to take corrective action.

3. Keeping in view of the above and in order to avoid such recurrence of incidents in future pertaining to filling Land Acquisition Appeals by the State, it has been decided to constitute a Committee under the Chairmanship of Chief Secretary comprising of following members, to look after the issue of timely filing of appeals in Land Acquisition matters/case, if any.

- (ii) Complete time frame should be provided for applying and/or receiving certified copies, preparation of Appeals, sanctioning of requisite funds, drawing up and filing up of Appeals, etc.
- (iii) The guidelines shall also provide for due co-ordination between different departments of the State Government.
- (iv) To examine for constituting a Centralised Nodal Office to ensure timely filing of Appeals in the High Court, in order to avoid any consequences adverse to the interest of the State including burdening the public exchequer.

(v) The guidelines so framed shall also introduce the Principal of Public Accountability and Answerability for inaction/action of various authorities in the State hierarchy in such cases.

(vi) The guidelines shall include fixing responsibility and take action against erring officials. Possibility shall also be explored for fixing responsibility on Government pleaders incase of lapse on their part. The guidelines may also make powers to block their professional case, incase of failure on the part of the Government advocate and the additional Government advocate.
