As per the Government Notification No. 13/2/92-SWD dated 17-07-1996, the District Magistrate of South Goa, Margao had constituted District Level Vigilance and Monitoring Committee vide Order No. 39/15/2000-MAG/1713 dated 10-09-07 in pursuance of Rule 17 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Rules, 1995 (hereinafter referred to as "the said Rules").

During the meeting held on 17-08-2016, the representative of Member Secretary, District Level Vigilance and Monitoring Committee, reviewed the provision laid under Rule 17(2) of POA Rules, 1995 regarding composition of District Level Vigilance and Monitoring Committee. Rule 17(2) envisages for constitution of the Committee and as per the present District Level Vigilance and Monitoring Committee, it was informed out that there is a shortfall of the composition of the members as mentioned in Rule 17(2) of POA Rules, 1995.
