INVITING APPLICATION FOR THE POST OF ONE MEMBER OF CHILD WELFARE COMMITTEE (SOUTH GOA)

Department of Women and Child Development, invites applications from eligible persons for the post of one member of the Child Welfare Committee South Goa constituted under Section 27 of the Juvenile Justice (Care and Protection of Children) Act, 2015 read Rule 15 of the Goa Juvenile Justice (Care and Protection of the Children) Model Rules, 2016 .

Qualification for Chairperson and Members of the Committee:-

- 1) A person to be selected as a Chairperson or member of the Committee shall have either of the following qualification in addition to a minimum of seven years of experience of working with children in the field of Education, health or welfare activities, or should be practicing professional with a degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer will be considered.
- 2) The Chairperson and the members of the Committee shall be above the age of thirty five years.
- 3) The members of the Committee shall be eligible for appointment of maximum of two terms, which shall not be continuous.

Functions and duties of the Committee:-

- 1) Child Welfare Committee shall have minimum 20 sitting per months as per the provision of the Section 27 of the Juvenile Justice (Care and Protection of Children) Act, 2015.
- 2) Child Welfare Committee shall sit on all working days for a minimum of six hours commensurate with the working hours of a magistrate court as per the provision of the Section 16 sub rule 7 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016
- 3) As per the provision of the Section 16 sub rule 1 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016 the remuneration to be paid to Child Welfare Committee shall pay sitting allowance of Rs. 1500/- per sitting
- 4) Child Welfare Committee shall have office/sitting in the premises of the Apna Ghar, Mercedes, Tiswadi, Goa and Child Care Institutions situated all over Goa.

Other conditions:-

- 1) Preferably the candidates from the residential District shall be consider for the appointment of the above committees for that particular District (South) Goa.
- 2) Government Servant/ Co-operation / Autonomous Bodies where may not be apply for the said post .
- 3) Knowledge of the Konkani, Marathi, Hindi and English should able to speak.
- 4) Sitting of the Child Welfare Committee shall be minimum 20 days (i.e 6 hours) per months is required

The Selection of the Chairperson and Members will be made by 6 members of Selection Committee Chaired by Retired Judge of High Court under Rule 87 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016. The Selection will be subject to the provision of the Juvenile Justice (Care and Protection of Children) Act, 2015 and the Juvenile Justice (Care and Protection of Children) Model Rules, 2016.
