INVITING APPLICATION FOR THE POST OF MEMBERS OF JUVENILE JUSTICE BOARD (NORTH / SOUTH GOA)

The Government of Goa invites application from individual fulfilling the following prerequisites for the appointment of member(s) of the Juvenile Justice Board North Goa and Juvenile Justice Board South Goa District at Apna Ghar, Merces - Goa.

Qualification for Members of the Juvenile Justice Board:

- A person to be selected as a Member of the Board shall have either of the following qualification in addition to a minimum of seven years of experience of working with children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law.
- 2) The members of the Board shall be above the age of thirty five years.
- The members of the Committee shall be eligible for appointment of maximum of two terms, which shall not be continuous.

Functions and duties of the Committee:-

- The Board shall sit on all working days for a minimum of six hours as per the provision of the Rule 6(7) of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016.
- 2) As per the provision of the Rule 6(9) of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016, the remuneration to be paid to Members shall be sitting allowance of Rs. 1500/- per sitting
- The members shall have office/sitting in the premises of the Apna Ghar, Merces, Tiswadi, Goa and also at D-1-6, PWD Residential Complex, Fatorda, Margao Goa.
- 4) A person appointed shall be willing to undergo training and orientation programme of 10 to 15 days outside the State of Goa.

Other conditions:-

- 1) Preferably the candidates from the residential District shall be considered for the appointment of the above committees for that particular District (North/South) Goa.
- 2) Government Servant/ Co-operation / Autonomous Bodies may not apply for the said post.
- 3) Candidates should possess knowledge of Konkani, Marathi, Hindi and English.

The Selection of the Members will be made by 07 members of Selection Committee Chaired by Retired Judge of High Court under Rule 87 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016. The Selection will be subject to the provision of the Juvenile Justice (Care and Protection of Children) Act, 2015 and the Juvenile Justice (Care and Protection of Children) Model Rules, 2016.

The desirous persons who are eligible may submit their application as per the proforma advertised, addressed to the Director, Women and Child Development, 2nd Floor, Old Education Dept. Bldg., 18th June Road, Panaji-403001 with 01 passport size photo attached on the application and self attested copies of all qualification certificates, Birth Certificate and other documents along with names, addresses and contact numbers of two references of reputed persons in the State. Applications complete in all respect should be submitted <u>on or before 1/06/2024</u>. Incomplete applications and those without supporting documents will be rejected at first instance.
