BRIEF FACTS

The Appellant filed his first appeal on 25/11/2024 under section 19 (1) of the Right to Information Act, 2005 and received by the office of the First Appellate Authority (FAA) on 25/11/2024 in connection with his application dated 24/10/2024 to provide information from PIO/Social welfare Officer.

2. The appellant has informed that no information has been provided.
3. Notices were issued to both the parties requesting therein to remain present on 10/12/2024 at 11.30 a.m.
4. The Appellant did not appear on 10/12/2024 at 11.30 a.m. to said schedule nor he sent any communication to this office, besides acknowledgement of Notice dated 29/11/2024. Respondent present is instructed to read the word Dy. Director (ADMIN) instead of Director at the 1st para of the

Notice and matter kept on 23/12/2024 at 11.30 a.m. as a last chance to the Appellant.

5. On 23/12/2024 appellant again did not appear on the said schedule nor he sent any communication to this office. Respondent filed reply.
6. PIO vide reply informed that she has already sent a letter dated 22/11/2024 to the Appellant requesting therein to collect the same by paying an amount of Rs.62/- through Register A/D which was registered to him on 25/11/2024 i.e. on Monday, for being Saturday and Sunday on 23/11/2024 and 24/11/2024 respectively. The said Register A/D is acknowledged by the Appellant on 26/11/2024.
7. Matter kept for order after 1 hour on the same day.
8. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on the record.

ORDER

Respondent to provide pointwise desired information to the Appellant under intimation to the undersigned by 07/01/2025. Copy of this order be sent to the appellant and PIO/Respondent.

Pronounced. Proceedings stands closed, accordingly matter stands disposed off.

Aggrieved party, if any is not satisfied with this order, he may file an appeal before Goa State Information Commission.
