**INVITING APPLICATIONS FOR THE POST OF CHAIRPERSON AND MEMBERS OF
CHILD WELFARE COMMITTEE (NORTH / SOUTH GOA)**

Department of Women and Child Development, invites applications from eligible persons for the posts of Chairperson and Members of the Child Welfare Committee North and South Goa District to be constituted under Section 27 of the Juvenile Justice (Care and Protection of Children) Amendment Act, 2021 and Rule 15 of the Juvenile Justice (Care and Protection of the Children) Amendment Rules, 2022 as under:

1. Chairperson -- 1 Post North Goa District/ 1 Post South Goa District
2. Members -- 4 Posts North Goa District/ 4 Posts South Goa District

Qualification for Chairperson and Members of the Committee:-

1. The Chairperson and the members shall be above the age of thirty-five years and not more than sixty five years and shall have a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children and has been actively involved in health, education or welfare activities pertaining to children for seven years or is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children.
2. The members of the Committee shall be eligible for appointment of maximum of two terms, which shall not be continuous. Provided that nothing contained in this sub-rule shall be a bar in case of a member being appointed as Chairperson.
3. The person applying for the post of the Chairperson or member of the Committee shall submit an affidavit, as per Form 49, certifying that the applicant is not barred by any of the conditions laid down in subsection 4A of section 27 of the Juvenile Justice (Care and Protection of Children) Amendment Act 2021. The appropriate Government shall then verify the same as per norm.
4. A person associated with an organisation receiving foreign contribution shall not be eligible to be a Chairperson or member of the Committee.
5. Any person working in the implementation of the Act in any Non-Government Organisation or any organisation, performing such functions which may cause conflict of interest in discharge of their duties as the Chairperson or member of the Committee shall not be eligible for appointment as the Chairperson and member of the Committee.
6. In continuation to the above, this may also include the following situations within the territorial jurisdiction of the committee.
 - (a) any family member is a member of any non-governmental organisation;
 - (b) close relation is a member of any non-governmental organisation ;
 - (c) cases of non-governmental organisations or persons working in a district for rescue and rehabilitation;
 - (d) a person representing a person who runs a Child Care Institution or member of the Board or Trust of any non-governmental organisation.

Functions and duties of the Committee:-

- 1) Child Welfare Committee shall meet at least twenty days in a month as per the provision of Section 28(1) of the Juvenile Justice (Care and Protection of Children) Act, 2015.
- 2) Child Welfare Committee shall sit on all working days for a minimum of six hours commensurate with the working hours of a Magistrate Court as per the provision of Rule 16(7) of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016.

- 3) The Chairperson and members of the Committee shall be paid such sitting allowance, travel allowance and any other allowance of Rs. 1500/- per sitting, as per the provision of Rule 16(1) of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016.
- 4) Child Welfare Committee shall have office/sitting in the premises of the Apna Ghar, Mercedes, Tiswadi, Goa; at D-type Quarters bearing No. D-1-6, PWD Residential Complex, Fatorda, Margao, Goa and at Child Care Institutions situated all over Goa.

Other conditions:-

- 1) Preferably the candidates from the residential District shall be considered for the appointment of the above committees for that particular District (North/South) Goa.
- 2) Government Servant/ Co-operation / Autonomous Bodies may not apply for the said post.
- 3) Candidates should possess knowledge of Konkani, Marathi, Hindi and English.

The Selection of the Chairperson and Members will be made by the Selection Committee chaired by the Retired Judge of the High Court under Rule 87 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016. The Selection will be subject to the provision of the Juvenile Justice (Care and Protection of Children) Amendment Act, 2021 and the Juvenile Justice (Care and Protection of Children) Amendment Rules, 2022.

Interested candidates fulfilling eligibility criteria must submit their application as per the proforma available on the website of this Department www.dwcd.goa.gov.in addressed to the Director, Women and Child Development, 2nd Floor, Old Education Dept. Bldg., 18th June Road, Panaji-403001 with 2 copies of colored photographs and self-attested copies of all qualification certificates, Birth Certificate and other documents alongwith the names, addresses and contact numbers of two references of reputed persons in the State and an affidavit in FORM 49 (format available on the website) to be submitted **on or before 17/03/2025** during office hours at the address as mentioned above. Incomplete applications and those without supporting documents shall be liable for outright rejection.
