**The online application should accompany the following documents (scan and upload on the e-tender website):**

- a) Registration certificate of the company/firm.
- b) GST Registration certificate.
- c) Partnership deed in case of partnership firm.
- d) Copy of PAN card, duly certified displaying the PAN No.
- e) Mode of payment towards cost of the Tender Documents, EMD & Tender Processing fee:
  - 1) Internet banking: payment can be made through the internet banking of any bank.
  - 2) NEFT/RTGS (National Electronic Fund Transfer/Real Time Gross Settlement): Bidders are required to download NEFT/RTGS challan and make payment to dynamically generated Account No. through any of the bank.

**INSTRUCTIONS TO THE BIDDER**

1. Information and Instructions for bidders posted on the website shall form part of the bid document.
2. The bidder can download the bid from website <https://eprocure.goa.gov.in>.
3. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
4. The intending bidder must have / obtain a valid Class-III digital signature to submit the bid.

5. On opening date, the contractor can login and see the bid opening process. After opening of bids they will receive the competitor bid sheets.
6. Bidder must ensure to quote rate for each block. The column meant for quoting rate in figures appears in sky blue colour (Rupees in words will be automatically taken).
7. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO) & will be treated as incomplete tender & will be rejected outright. Also name of the bidder should be entered in the respective cell.
8. At the time of opening, the scanned copies of the Documents uploaded at the time of submission of tender will be verified with the physical/hard copies submitted and bids of only those contractors whose physical copies matches with the uploaded copies will be accepted for opening.
9. ENVELOPE should be superscribed with "Name of Work, Serial Number of Work and Name of Bidder" and should contain the following:
  - a) Registration certificate of the company/firm
  - b) Sales tax/VAT/GST registration certificate
  - c) Partnership deed in case of partnership firm
  - d) Copy of PAN card, duly certified displaying the PAN No.
  - e) The copy of NEFT/RTGS/Net banking challan, cost of the Tender document, EMD & Tender processing fee.

The ENVELOPE (technical bid along with sample pre-school kit) should be dropped in the tender box on upto 15.00 hrs on or before 10/03/2025, kept in the office of the **Directorate of Women & Child Development**, 2<sup>nd</sup> Floor, Old Education Building, 18<sup>th</sup> June Road, Panaji, Goa.
